Knox Christian School TUITION ARREARS POLICY

POLICY

The following procedures will be followed for families who fall behind in their tuition payments as they have outlined in the Knox Tuition Form payment options.

- After 30 Days: A tuition statement letter will be sent detailing the amount in arrears, requesting payment for amount owing.
- 2. **After 45 Days:** A phone call from a member of the Finance Committee reminding them of their arrears and requesting payment.
- 3. **After 60 Days:** A visit by two members of the Finance Committee will be arranged. A personal evaluation of the financial situation will be made and a recommendation made to the Knox Board.

 This may include a revised plan; however, all outstanding tuition payments must be paid by July 31 of the current school year. Should tuition still be in arrears, the parents will not be permitted to register their children the following year, and report cards will not be released. This will be waived when the tuition arrears are paid in full.
- 4. After 90 Days: The Knox Board will be fully informed of the arrears account, and reserves the right to notify the family by registered mail that attendance will be denied for Knox Christian School until all financial accounts have been cleared. Parents lose their privilege of attending or voting at Society Meetings.

All N.S.F. cheques will result in a \$30 charge/incident.

The board may exercise the right to take legal action as part of its fiduciary responsibilities

Summary:

With the privilege of providing Christian education to our school children also comes the responsibility of meeting our obligations towards the financial wellbeing of the school. Each family is expected to cooperate with the school administrative body through prompt and timely payment of tuition to ensure the continuing availability of quality Christian education at Knox Christian School.
